**Transfer Agreement
between
Southern Vermont College and
Kingsborough Community College**

Southern Vermont College (SVC) and Kingsborough Community College (KCC) enter into this agreement to provide qualified KCC graduates the opportunity to pursue a bachelor's degree from SVC.

Transfer Credit

All non-remedial KCC classes in which the student has earned at least a 'C' will transfer to SVC. However, those students pursuing a bachelor's degree in Nursing or Radiologic Sciences must earn at least a 'C+' for the following classes to transfer: Anatomy & Physiology I, Anatomy & Physiology II, College Algebra, Introduction to Healthcare I, and Introduction to Healthcare II.

Conditions of Transfer

Students who earn their associate's degree from KCC with a 2.0 or higher GPA will be accepted into SVC. Southern Vermont College will accept and apply 60 degree credits toward the SVC bachelor's degree.

The SVC application fee will be waived.

SVC Bachelor Degree Completion Requirements:

A KCC graduate must complete a minimum of 60 additional graded credits at Southern Vermont College in order to be eligible to receive a bachelor's degree from SVC. The graduate must successfully complete all baccalaureate degree requirements in order to receive an SVC baccalaureate degree. The student's SVC cumulative GPA is calculated using credits earned at SVC only.

Kingsborough Community College agrees to:

1. Provide periodic opportunities on the KCC campus for Southern Vermont College admissions counselors to advise KCC students interested in transfer;
2. Distribute informational materials about the transfer program to KCC students;
3. Include information regarding the availability of transfer to Southern Vermont College in KCC materials in which transfer agreements are described;
4. Notify SVC of college transfer fairs held at KCC; and
5. Provide a KCC staff member as a contact for SVC admissions staff.


Southern Vermont College agrees to:


1. Periodically send SVC admissions counselors to KCC to advise students interested in transfer;
2. Provide informational materials about the transfer program to KCC;
3. Include information regarding the transfer program in appropriate SVC materials;
4. Send an admissions counselor to KCC transfer fairs; and
5. Provide and SVC staff members as a contact person for the KCC staff.


