President Peruggi called the meeting to order at 3:10 p.m.

I. The minutes of the meeting of September 25, 2007 were approved unanimously.

II. Reports

A. President's Report

President Peruggi reported that the total enrollment for the Fall 2007 semester was 14,490, a figure that was flat compared to the prior year. Enrollment numbers without College Now were 11,449, actually up 1% from the prior year.

The budget news for the coming years is gloomy. The City and State fiscal outlook has been negatively affected by the real estate slump. The City has required that the University make cuts for the next years and the University has asked us to file a PEG (Program to Eliminate the Gap). Our share of the cut is \$375,000. For the next academic year, our share will be \$1.3 million. Compounding this cutback is the flat enrollment over the past few years which has resulted in lost revenue. This year we will be \$1 million short in meeting our budget figures. We will need to recruit more students to supplement the loss of My Turn students and the closure of the Teachers on Sabbatical Program.

Spring Convocation, on Friday February 29, 2008 will consist of two parts. Professor William Peltz, Professor of Psychology at Herkimer County Community College, SUNY, will be the keynote speaker. He will address the use of technology in education. This will be followed by workshops run by our own faculty who will demonstrate how they are using technology in the classroom.

President Peruggi also mentioned that she had completed meeting with the academic departments and was happy with the responses and projects currently being undertaken by the faculty. She also thanked all the people who were instrumental in running recent Campus-wide events, such as the International Hall of Flags dedication, the christening of the RV Drucker, the "Eyes Wide Open" exhibit and the student club activities.

Most notable was the fundraiser run by students which was able to collect \$4,073 dollars for St. Jude's Research Center.

B. Committee on Budget

Dean Fox reported that the Budget Committee was consulting with the administration on the CUNY Compact. The CUNY Compact was to be a program whereby the State and City invested in CUNY, the colleges raised money to contribute, and tuition increases would be planned and predictable. CUNY is proposing \$4,101,000 for Kingsborough's 2008-2009 Compact Programmatic Initiatives. The following are the categories given to us by CUNY- we may only transfer up to 20% between categories. The ultimate decisions regarding Compact expenditures rest mostly with the college administration but CUNY requires that in the planning it consult with the governance body and with students. Because of its role in planning, the consultation is being done through the Budget Committee.

1. Strengthening the Flagship Environment includes hiring full-time faculty and faculty support. \$1,544,500 is requested for this area.
2. Fostering a Research Environment includes support for faculty and student research and \$579,600 is requested for this area.
3. Student Services – advising and counseling, facilitation of financial aid, etc. - \$453,600
4. Workforce and Economic Development – creating career pathways through non-credit and credit programs - \$307,900
5. Information Management Systems – including support for CUNY FIRST - \$645,600
6. Upgrading Facilities Infrastructure - \$570,000
