Rationale for Change:

As the course description states, Art 55 supplies the groundwork necessary to all studio courses. At the moment Art 55 is prerequisite only for Art 43 and Art 46. This is inconsistent. The degree maps list Art 55 in the first semester and Art 75 in the last semester.

It is best for student success and proper knowledge build up that Art 55 is taken before Art 75.
