The Department of Health, Physical Education and Recreation is requesting that the Prerequisite for PEC 66 *Intermediate Yoga* be changed.

Rationale for Change: The PEC 82XX course designation was utilized when the course was first offered as a pilot. After running successfully, it was assigned a permanent number, PEC 6700. However, it was not changed in the catalog and in other course registration materials. This has caused confusion when students attempt to register for PEC 66.
