The Department of Business is proposing a change in Course Title and Description for BF3500 – Textiles and Non-Textiles

FROM:
BF3500 - Textiles and Non-Textiles

The course familiarizes students with fashion fabrics, including their identification, characteristics, merits, limitations, care, and with the product development, from research to product distribution, of non-textiles products.

TO:
BF3500 - Textiles

The course familiarizes students with fashion fabrics, including their identification, characteristics, merits, limitations, care, sustainability and with the product development, from research to product distribution.

Rationale for Change:

When we changed over to the Business of Fashion program, from Fashion Merchandising with a Fashion Concentration we added a new course in Product Development BF3200 which covers the non-textile component of what was originally covered in the last few weeks of the Textile class. My suggestion is to take the non-Textile component out of BF3500 Textiles and Non-Textiles changing it to BF3500 Textiles, it will allow class time to add the topic of sustainability, which is a major trend in Textiles today. Other Fashion Colleges offer Textiles as a separate class, which would aid in transferring credits.
