2012- 2013 SATISFACTORY ACADEMIC PROGRESS APPEAL

Federal regulations require financial aid recipients to maintain satisfactory academic progress (SAP) towards a degree. You are on financial aid suspension because academic records show that you have failed to meet SAP standards in one or both of the following categories:

CUMULATIVE GPA	Your GPA has fallen below SAP requirements (See chart on reverse)
PACE OF PROGRESSION	 Your attempted credits exceed 150% of the credits required for completion of the degree (See chart on reverse) Did not complete required percentage of attempted credits(See chart on reverse)

You may appeal this suspension by submitting this form to the Financial Aid Office. Appeals will be evaluated for mitigating circumstances only, such as serious illness, as well as the ability to meet the standard within reasonable time. All appeals will be evaluated on case by case basis. Please allow at least15 business days for a decision. All Committee decisions are FINAL.

Submission of the appeal does not guarantee approval. Students are responsible for their tuition and any late fees regardless of their financial aid status.

STEPS TO FILE AN APPEAL

1. Submit this appeal and all **supporting documents** to the Financial Aid Office (U201).

Your appeal will be reviewed by the Committee and a letter will be sent informing you of the decision. You may also check your CUNY portal.

- * Failure to submit supporting documentation may result in a denial of your request.
- 2. If your appeal is approved, you will be placed on probation and must follow an academic plan designated by a Financial Aid Counselor. You will be eligible to receive financial aid provided that you meet the terms and conditions of your academic plan. If your appeal is denied, you will be not eligible for financial aid and will need to seek alternative financial resources.
